IMPORTANT.

 (c) Applicants must await the Company's notice of acceptance before proceeding with the installation.
 (d) Applicants must notify the Company of any additions to wiring or apparatus installed after the supply has been connected.
 (e) Applicants should carefully read the conditions printed on the reverse side hereof, also the Schedule of Charges issued with this form.
 (f) The Company reserves the right to determine the point of entry of the service into the premises and to fix the position of the meter or meters at the nearest possible point. (Vide Condition No. 7.)
